## **PUBLIC WORKSHOP TO DISCUSS POSSIBLE MODIFICATIONS TO THE ZERO-EMISSION VEHICLE (ZEV) REGULATIONS**

A public workshop to discuss proposed amendments to the Air Resources Board's (ARB or Board) ZEV program is scheduled for December 5 & 6, 2002. The proposed changes are designed to address issues raised by industry litigation and to take into account current conditions and trends in zero and near-zero emissions technology development. ARB staff will present initial ideas for addressing these issues and the rationale for such changes. Comments and public input presented at the workshop will be used in drafting a final proposal for the Board's consideration at its hearing on February 27 & 28, 2003.
